- 4. Any letter of resignation submitted by the contractual specialists will be treated as a letter communicating the intention of the contractual doctor to terminate the contract. If a contractual specialists wishes to terminate the contract by giving 90 (ninety) days notice it would be accepted by the Medical Director of the institution, after getting a no dues certificate from the branches concerned. No notice is required, if service is terminated on disciplinary grounds/falsification of declared information/joining of regular incumbent.
- 5. Private Practice of any kind is not allowed.
- 6.Contractual Specialists are governed only by the terms and conditions mentioned in the contract agreement and not by any other rules for grant of leave benefits, LTC benefits, GPF, Pension Benefits, DGHS, Provisions of FR/SR etc., that are applicable to only regularly appointed doctors of Government of NCT of Delhi. Specialists engaged on contract basis on consolidated remuneration will not be entitled for any other allowances, financial benefits or concessions of medical facilities as admissible to regular Government Doctors.
- 7. The timings of work/duties/responsibilities of contractual engagement would generally be same as those of regular appointed specialists.

- 8. The above posts shall be filled on regular basis through UPSC and the contractual doctors will have no claim on regular recruitment solely because of contractual engagement served at the concerned hospital.
- 9. SC/ST certificates issued only from Competent Judicial/Revenue authorities shall be accepted.
- 10. For candidates for OBC/EWS category, the certificate must be issued by the Competent Authority of Govt Of NCT of Delhi. OBC/EWS certificates issued from Govt. Of NCT of Delhi shall only be accepted, OBC candidates must have Non-Creamy Layer Certificate valid for financial year 2024-25.
